

Hi Kerstin,

I have the information taken from FMO website which the Health Unit is going by as well. I have spoken on the phone with the Health Unit. Following is the info from the FMO:

Public Safety Protocols for Ontario's Farmers' Markets

Updated June 5, 2020

Farmers' markets, as businesses that primarily sell food, are considered essential workplaces under Ontario's Emergency Order. As such, two models of farmers' market may operate, with the appropriate approvals, during this time.

The protocols that follow for each model have been developed in consultation with public health officials and must be reviewed and adapted in consultation with the <u>local public health unit</u> to meet each market's specific operational requirements.

This is not business as usual for markets as social interaction must be limited to maintain physical distancing to ensure the health and safety of vendors and customers.

OPTION 1: Protocols for multi-vendor, multi-stand market

Market managers/organizers must ensure:

- 1. Their landlord/property owner approves.
- 2. They contact their <u>local public health unit</u> (PHU) and present a plan (including a diagram showing a proposed market layout and a complete list of vendors and their products) and review this protocol adapting the plan, as required by the PHU, based on their operation/location.
- 3. The majority of vendors must be selling food, other consumer products and art and craft may be sold.
- Stands are spaced out and customer circulation is monitored or controlled (perhaps one-way movement) to maintain social distancing and shoppers time at the market.

Since we have 8 food vendors we are allowed to have 7 craft vendors going by this protocol which is 1 less than our food vendors.

Subject: Adding Vendors to the Magnetawan Farmers Market

To Kerstin,

I was recently contacted by our local health inspector Lou D'Allessandro of the North Bay Parry Sound Public Health Unit and informed that the Magnetawan Market can now add artisans/crafters to the market per new provincial and health unit guidelines as long as the Town is in agreement. As per the new plan, there still needs to be more food vendors than crafters, but that means we could add an additional 7 vendors to the market. I am seeking the approval of the town to go ahead and add in 7 additional vendors to the 8 food

vendors we currently have. There is ample room inside the pavilion and adding these vendors will still allow 10ft of space between each vendor, which follows the rules laid out. Traffic into the pavilion will be controlled via one entrance/exit as it was this past Saturday and clearly marked for customers to see. All the guidelines currently in place for food vendors will apply to the added vendors, including each having a hand washing station available at their booth for their own use when in the past that requirement was for food vendors only. They must also have either a barrier of some sort or wear a mask at all times if they do not have a barrier. Physical distancing is clearly marked on the floor as well as enforced in the line-up area to get into the pavilion.

As it was this past Saturday, at the entrance to the market our customers will be greeted by myself and a volunteer who will have all the information about protocols and will convey that the washrooms are closed, that shoppers must remain 6ft apart and that only a certain number will be allowed into the pavilion at a time. We also have hand sanitizer on site for each guest to use before entering. Overall it was successful market day and customers were respectful of the rules and new protocols.
