## Temporary Zoning By-law Application – Stewart – 100 Jackson Road

# 2.3 Request Purchase Unopened Road Allowance – Sadlon – Con 5 PT Lot 16 Pt 1 to 4 – 42R-8407

**RESOLUTION 2024-343 Hind-Kneller** 

WHEREAS in 2004 the Council of the Municipality of Magnetawan denied the request from Graham Wilson & Green solicitors for the Owner (Sadlon) to purchase the area of the Unopened Road Allowance to which the boathouse, shown in the provided site sketch, encroaches on municipal lands;

AND WHEREAS in 2006 an Encroachment Agreement was entered into for the property legally described as Con 5 PT Lot 16 PT 1 to 4, 42R-8407, Municipally known as 410 15th/16th Sideroad to permit the encroaching structure(s);

AND WHEREAS the Municipality is closing out Encroachment Agreements;

NOW THEREFORE BE IT RESOLVED THAT the Council of the Municipality of Magnetawan agrees in principle to sell a portion of the Municipally-owned Unopened Road Allowance surrounding the encroaching structure(s) with the following conditions:

- Only includes the Unopened Road Allowance lands within 2 metres of the encroaching structure;
- A reference plan depicting the subject lands to the satisfaction of the Municipality be provided;
- All costs incurred by and/or imposed by the Municipality arising from and in consequence of the application and the proposed closure and sale be borne by the Owner;

- The price of the land shall be determined by a qualitied appraiser;
- The lawyer to provide an undertaking to merge the encroached lands to the subject lands to Con 5 PT Lot 16 PT 1 to 4, 42R-8407 within 3 months of registration;
- Confirmation be provided to the Municipality that the Applicant has legal title of the subject lands.

Deferred.

Direction was given to Staff to reach out to the owner of the abutting property and to notify them of the request for purchase and offer same.

WHEREAS the trailer used by the Almaguin Community Hatchery Program is under the ownership of the Municipality of Magnetawan;

AND WHEREAS the current Municipal insurance only covers the replacement value of the trailer at \$9,400 and does not cover the value of the scientific equipment and contents which are valued at \$156,000;

AND WHEREAS the additional cost of insuring the contents of the trailer would be a cost of \$550 annually on the Municipal Insurance Policy;

NOW THEREFORE BE IT RESOLVED that the Council of the Municipality of Magnetawan approves the additional cost of insurance for the Hatchery Trailer and contents. Carried.

## RESOLUTION 2024-354 Bishop-Hetherington

WHEREAS the Municipality of Magnetawan recognizes how vital the Forestry Industry is to the Economy in Ontario and the success of the forest sector is critical to the economic and social prosperity of Ontario communities, employing 137,000 people;

AND WHEREAS the forest industry has invested over \$3.8 billion in Ontario since 2018 and Ontario has an opportunity to market global investment in the bioeconomy, similar to critical minerals and electric vehicle manufacturing, and become a leading internation jurisdiction;

AND WHEREAS over the last 20 years, the North American pulp and paper sector has seen a significant rationalization in production capacity, with investment dollars going to competing internation jurisdictions, and

in the last year, Ontario has seen three pulp, paper, and containerboard mills idle or close, negatively impacting communities and the solid wood mills that depend on these facilities as markets for mill by-products and pulpwood;

AND WHEREAS U.S. tariffs on softwood lumber are expected to double in 2025, to approximately 30% and Ontario should work with federal colleagues to pursue a softwood lumber settlement that works in the best interests of Ontario lumber producers and advocate for a financial backstop;

AND WHEREAS Ontario has an opportunity to procure greater amounts of energy (i.e., electricity, heat, fuels, biochar, etc.) from forestry by-products and forests to assist in heavy industry decarbonization and Ontario's forecasted electricity demands;

AND WHEREAS Ontario's successful and oversubscribed Forest Biomass Program should continue post-2027;

AND WHEREAS Ontario will actively seek investment to restart idled softwood kraft lines in Ontario and Quebec to provide immediate relief for some sawmill producers and Ontario's \$10 million Sawmill Chip Program, ending March 25, 2025, will likely need to continue and expand in the absence of an immediate restart of a currently idled pulp mill to avoid curtailments at solid wood facilities;

AND WHEREAS 5-year bilateral power purchase agreements (PPAs) with forest biomass-fired electrical generation facilities are sufficient and should be expanded both in terms of length and volume to provide communities, industry, and works with a certain future; AND WHEREAS the public Forest Access Roads Funding Program, which provides for public use of Ontario's forests, should be increased to \$75 million/year to reflect inflationary pressures and support legacy infrastructure upgrades (i.e. roads, bridges, and water crossings).

NOW THEREFORE BE IT RESOLVED THAT the Council of the Municipality of Magnetawan supports the implementation of the Ontario Forst Industries Association's 2025 Ontario Budget Recommendations in support of attracting investment and maintaining forest operations and employment in Ontario.

#### RESOLUTION 2024-355 Kneller-Hind

WHEREAS official statistics from the Government of Ontario confirm that rural roads are inherently more dangerous than other roads;

AND WHEREAS, rural, northern, and remote municipalities are fiscally strained by maintain extensive road networks on a smaller tax base;

AND WHEREAS, preventing crashes reduces the burden on Ontario's already strained rural strained health care system;

AND WHEREAS, roadway collisions and associated lawsuits are significant factors in runaway municipal insurance premiums. Preventing crashes can have a significant impact in improving municipal risk profiles;

NOW THEREFORE BE IT RESOLVED THAT the Council of the Municipality of Magnetawan requests that the Government of Ontario take action to implement the rural safety program that Good Roads has committed to lead. It will allow Ontario's rural municipalities to make the critical investments needed to reduce the high number of people being killed and seriously injured on Ontario's rural roads;

AND FURTHER THAT a copy of this resolution be forwarded to Premier Doug Ford, the Honourable Prabmeet Sarkaria, Minister of Transportation, the Honourable King Surma, Minister of Infrastructure, the Honourable Rob Flack, Minister of Agriculture, the Honourable Lisa Thompson, Minister of Rural Affairs, the Honourable Trevor Jones, Associate Minister of Emergency Preparedness and Response, and the Honourable Sylvia Jones, Minister of Health and Good Roads;

AND FURTHER THAT this resolution be circulated to all municipalities in Ontario requesting their support through AMCTO, the Federation of Northern Ontario Municipalities (FONOM), and the Association of Municipalities of Ontario (AMO). Carried.

BE IT RESOLVED THAT the Council of the Municipality of Magnetawan endorses and supports item 4.3 North Bay & Parry Sound Health Unit Perspectives from Northern Ontario For the Public Health Funding Review;

AND FURTHER THAT this resolution be circulated to Dr. Kieran Moore, Chief Medical Officer of Health, the Honourable Sylvia Jones, Ontario Minister of Health, Elizabeth Walker, Executive Lead, Office of the Chief Medical Officer of Health, Boards of Health of Ontario, the Honourable Vic Fedeli, MPP Nipissing, the Honourable Graydon Smith, MPP Muskoka Parry Sound, the Honourable John Vanthof, MPP Timiskaming-Cochrane, the District of Parry Sound Municipal Association (DPSMA), the Federation of Northern Ontario Municipalities (FONOM), the Association of Municipalities of Ontario (AMO), and all Ontario Municipalities through AMCTO.

## RESOLUTION 2024-357 Hind-Hetherington

WHEREAS municipalities face growing infrastructure needs, including roads, bridges, public transit, water systems, and other critical services, which are essential to community well-being and economic development;

AND WHEREAS the current sources of municipal revenue, including property taxes and user fees, are insufficient to meet these increasing demands for infrastructure investment;

AND WHEREAS the Province of Ontario currently collects the Land Transfer Tax (LTT) on property transactions in municipalities across the province, generating significant revenue that is not directly shared with municipalities;

AND WHEREAS the Federal Government collects the Goods and Services Tax (GST) on property transactions, a portion of which could be directed to municipalities to address local infrastructure needs;

AND WHEREAS redistributing a portion of the Provincial Land Transfer Tax and GST to municipalities would provide a predictable and sustainable source of funding for local infrastructure projects without creating a new tax burden on residents or homebuyers; AND WHEREAS a redistribution of a portion of the existing Land Transfer Tax and GST would allow municipalities to better plan and invest in long term infrastructure.

would allow municipalities to better plan and invest in long-term infrastructure initiatives, supporting local economic growth and improving the quality of life for residents;

NOW THEREFORE BE IT RESOLVED THAT the Council of the Municipality of Magnetawan formally requests the Provincial Government to consider redistributing a portion of the Land Transfer Tax collected on property transactions to municipalities;

AND FURTHER BE IT RESOLVED THAT the Council of the Municipality of Magnetawan calls on the Federal Government to allocate a percentage of the GST collected on property sales to municipalities;

AND FURTHER BE IT RESOLVED THAT this redistribution of the Land Transfer Tax and GST should be structured to provide predictable and sustainable funding to municipalities, allowing for better long-term planning and investment in infrastructure projects that benefit local communities, thus ensuring that local governments receive a fair share of the revenue to address critical infrastructure needs;

AND FURTHER BE IT RESOLVED THAT copies of this resolution be forwarded to Prime Minister Justin Trudeau, Premier Doug Ford, the Ontario Minister of Finance, the Minister of Municipal Affairs and Housing, local Members of Parliament (MPs) and Members of Provincial Parliament (MPPs);

AND FURTHER BE IT RESOLVED THAT copies of this resolution be forwarded to all 444 Municipalities in Ontario through AMCTO, the Federation of Canadian Municipalities (FCM), and the Association of Municipalities of Ontario (AMO) and the Federation of Northern Ontario Municipalities (FONOM), for their endorsement and advocacy.
