The regular meeting of the Council of the Corporation of the Municipality of Magnetawan was held at the Magnetawan Community Centre on Wednesday, September 26, 2018 at 1:00 P.M.

7.2.1. Renaming of Gordon Point Road

RESOLUTION 2018-296

Moved by Councillor Hetherington; Seconded by Councillor Gray:

WHEREAS there are two distinct roads in the Municipality that are both named Gordon Point Road, which has the potential to confuse and delay first responders in emergency situations; AND WHEREAS Magnetawan staff surveyed property owners along the least populated of the two roads – Gordon Point Road as accessed from Ahmic Lake Road – and twelve of thirteen owners responded, with nine owners providing support for changing the road name (69%); NOW THEREFORE BE IT RESOLVED THAT the Council of the Municipality of Magnetawan approves changing the name of Gordon Point Road as accessed from Ahmic Lake Road; AND FURTHER THAT the respective road maintenance group shall select and recommend an appropriate new name to Council for approval. (Deferred)

Council directed the DC to contact the Road Maintenance Group with the information on how the civic numbering system works.

Council directed the C-A to consult with the municipal solicitor regarding the potential disposal of or licensing of docks on municipally-owned land on Bayview Road. Council directed the C-A to circulate the information from the municipal solicitor to all the property owners on the road.

7.2.3. Application to purchase land, 86 Highway 510, Magnetawan

RESOLUTION 2018-297

Moved by Councillor Gray; Seconded by Councillor Crossman:

WHEREAS Richard, Bonita, Dale, and Blair Spencer, the owners of lands at Con B Part Lot 97 RP 42R13389 Part 2, in the Municipality of Magnetawan, and municipally known as 86 Highway 510, hereinafter referred to as "the Lands", has indicated a desire to purchase Original Road Allowance to the east of the Lands in order to obtain legal access to Provincial Highway 510; NOW THEREFORE BE IT RESOLVED THAT the Council of the Municipality of Magnetawan approves in principle the sale of Original Road Allowance to the owners of the Lands with the following provisions: THAT the application fee shall be waived, as the owners previously initiated, paid for, but never finalized an encroachment agreement application; THAT the deposit shall be set at \$2,500.00; and THAT the applicants shall follow the Magnetawan Procedures for Road Closing Applications. (Carried)

WHEREAS the Clerk-Administrator: posted internally for the position of Office Assistant as per the Collective Agreement with CUPE Local 1813-11 and received no applications; AND WHEREAS the Clerk-Administrator and Deputy Clerk: posted the position externally; received 124 applications; evaluated candidate applications against 21 criteria; conducted phone interviews with the top five candidates; re-evaluated; and conducted in-person interviews with the top two candidates; AND WHEREAS the Clerk-Administrator recommends top candidate Heidi Freistatter for hire; NOW THEREFORE BE IT RESOLVED THAT the Council of the Municipality of Magnetawan approves the hire of Heidi Freistatter for the position of Office Assistant; AND FURTHER THAT the Mayor and Clerk-Administrator be authorized to sign the contract of employment with Ms. Freistatter on behalf of the Municipality. (Carried)


