A BYLAW TO AUTHORIZE THE EXECUTION OF AN APPLICATION FOR APPROVAL TO EXPROPRIATE LAND AND NOTICE OF APPLICATION FOR APPROVAL TO EXPROPRIATE LAND

WHEREAS The Corporation of the Municipality of Magnetawan wishes to commence expropriation procedures for the acquisition of land for the purpose of the construction, maintenance and operation of public washrooms and public park, and related appurtenances thereto, and the land which it desires to acquire is described as:

Firstly: PART LOT 11, W/S NORTH SPARKS ST., PLAN 319 AS IN RO204165, EXCEPT THE EASEMENT THEREIN; AND PART LOT 11 W/S NORTH SPARKS ST., BEING PART 1, 42R3764; MUNICIPALITY OF MAGNETAWAN being all of PIN 52081-0930;

and

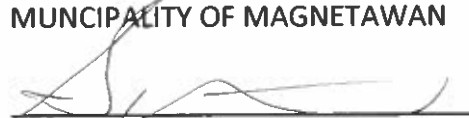

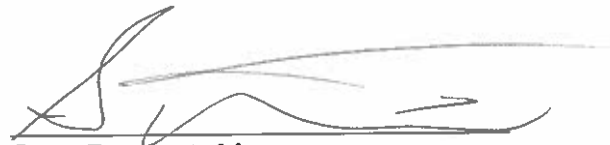

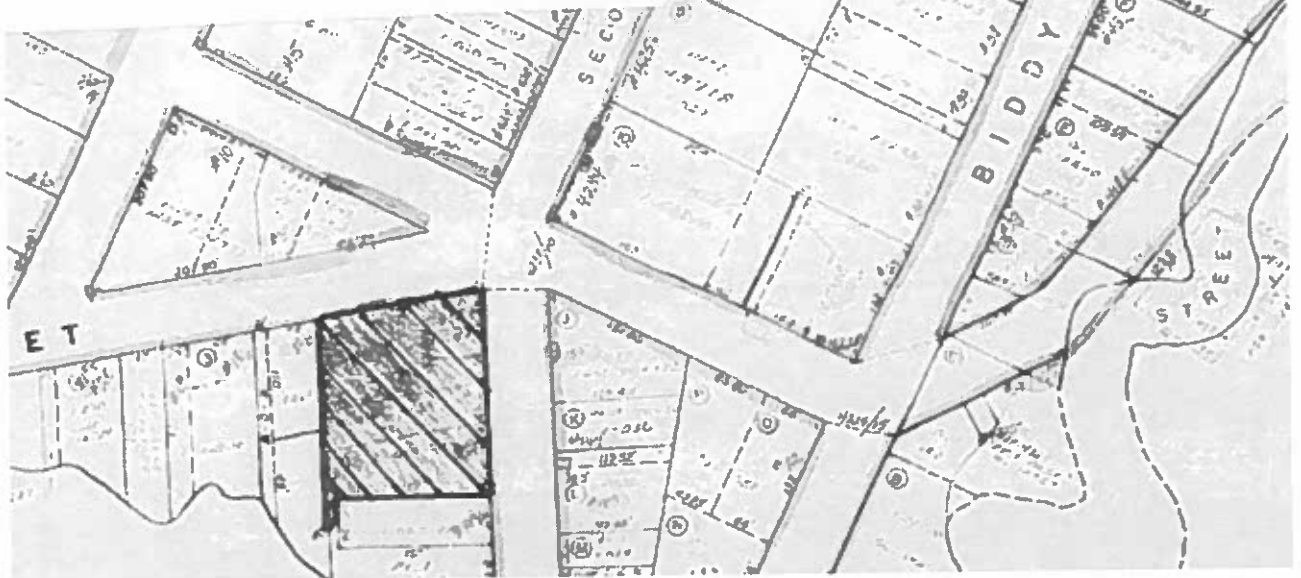

- b) in the case of an owner who is not a registered owner, within 30 days after the first publication of the notice.

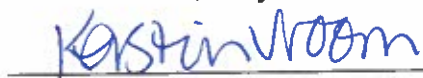
