Being a By-law to enter into an agreement with Yuk Yuks On Tour for the services of a comedian.

WHEREAS Section 5(3) of the *Municipal Act, 2001, S.O. 2001, c.25*, as amended, requires a municipal Council to exercise a municipal power, including a municipality's capacity, rights, powers and privileges under Section 9, by by-law unless the municipality is specifically authorized to do otherwise;

AND WHEREAS the Magnetawan Community Development Committee is hosting a Comedy Night on May 26, 2018 at the Magnetawan Community Centre;


AND WHEREAS the Council of the Municipality of Magnetawan deems it necessary to enter into an agreement with Yuk Yuk's On Tour for the services of a comedian;

NOW THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the Municipality of Magnetawan enacts as follows:


1. **THAT** the Corporation of the Municipality of Magnetawan is hereby authorized to enter into an agreement with Yuk Yuk's On Tour, attached hereto as Schedule 'A' and forming part of this By-law; and
2. **THAT** the Mayor and Clerk-Administrator are hereby authorized to execute the Agreement on behalf of the Corporation.

This limited license use ends the day following the final contracted show date(s) above.</p> <p>Purchaser to supply at Purchaser's cost a professional sound system with at least one microphone on a long cord attached to a round based straight microphone stand. House lighting should be dimmed, stage lighting should be white and focused on the performer's face(s). A bar stool should be placed at the rear of the stage area. It is important that the stage area be situated as close as possible to the seated audience. Purchaser to provide comedians with complimentary bottled water and soft drinks.</p>
