## **FOR PROVISION OF AN EMERGENCY OPERATIONS CENTRE**

April 27, 2016

THIS AGREEMENT MADE BETWEEN

#### THE CORPORATION OF THE TOWNSHIP OF RYERSON

(Hereinafter referred to as "Ryerson")

OF THE FIRST PART

# THE CORPORATION OF THE MUNICIPALITY OF MAGNETAWAN

(Hereinafter referred to as "Magnetawan")

OF THE SECOND PART

**WHEREAS** Section 20 (1) (2) of the *Municipal Act 2001 S.O. 2001, Chapter 25*, authorizes a municipality to enter into a joint agreement with one or more municipalities.

**AND WHEREAS** the Emergency Management and Civil Protection Act, R.S.O. 1990, c. E. 9. Sub Section 9 provides what a plan may provide; (e.1) and (f): provide for any other matter required by the standards for emergency plans set under section 14; and provide for such other matters as are considered necessary or advisable for the implementation of the emergency plan during an emergency.

**AND WHEREAS** the Parties have Emergency Plans pursuant to the Emergency Management and Civil Protection Act;

**AND WHEREAS** Ryerson has asked Magnetawan for the use of the Magnetawan Community Centre as an Alternate Emergency Operations Centre;

**AND WHEREAS** Magnetawan has agreed in principle to the use of the Magnetawan Community Centre as the Township of Ryerson's Alternate Emergency Operations Centre;

NOW THEREFORE the parties agree as follows:

 'The Centre' shall mean the Magnetawan Community Centre, located at 4304 Highway 520, Magnetawan, Ontario POA 1PO.

- 2. The Parties agree that in the event of:
  - a. a request by Ryerson for the use of The Centre as Ryerson's Alternate Emergency Operations Centre; and
  - b. the granting of Ryerson's request by the Mayor of the Municipality of Magnetawan or his/her designate;

then Magnetawan agrees to provide, where it is reasonably within Magnetawan's power to so provide: the Community Centre hall, accessible washrooms, use of the full kitchen, access to wireless internet, and a separate telephone line.

- 3. The parties agree that any and all direct costs for use of The Centre by Ryerson are to be paid by Ryerson. Ryerson shall be responsible to pay for any and all actual costs incurred by Magnetawan in providing The Centre to Ryerson.
- 4. Magnetawan will provide a detailed invoice to Ryerson. Ryerson will submit payment within thirty (30) days.
- 5. This agreement shall be in effect from the date on which the second party signs the agreement. Either party may terminate this Agreement upon at least sixty (60) days written notice to the other party.
