

## **ROADS UPDATE August 7 1:00PM**

AS OF JULY 7<sup>TH</sup>, 2025, 7AM THE MUNICIPALITY OF MAGNETAWAN DECLARED A SIGNIFICANT WEATHER EVENT UNDER O'Reg 239/02

THE ROAD CONDITIONS ARE IN A STATE OF REPAIR. PLEASE USE CAUTION AND JUDGEMENT WHILE TRAVELLING ON THE ROADS. STAFF IS EXPECTED TO BEGIN RESTORATION WORK STARTING NEXT WEEK.

WE ANTICIPATE THAT WORK WILL BE ONGOING OVER THE COMING MONTHS AS WE WORK ON RESTORING AFFECTED ROADS TO NORMAL STANDARDS.

RESIDENTS ARE ENCOURAGED TO REPORT ANY NEW SINKHOLES OR WASHOUTS TO THE MUNICIPAL OFFICE AT (705) 387-3947. WHEN LEAVING A MESSAGE PLEASE IDENTIFY THE ROAD AND THE CLOSEST CIVIC ADDRESS AS WELL AS A CALL BACK NUMBER.

DO NOT ATTEMPT TO DRIVE THROUGH FLOODING, WASHOUTS, AROUND BARRICADES OR TRAFFIC CONES

DO NOT ACTIVELY SEEK OUT WASHED OUT AREAS

YOUR COOPERATION IS GREATLY APPRECIATED AS WE WORK TO REPAIR OUR COMMUNITY'S INFRASTRUCTURE.
